EACH YEAR, THE THEATER PRODUCES BETWEEN 30-40 NEW AMERICAN PLAYS BY BOTH EMERGING WRITERS, ESTABLISHED WRITERS, AND THEATER COMPANIES THAT HAVE NO PERMANENT HOME.
